# Legislative Committee Update

The Legislative Committee looks forward to seeing everyone in Cheyenne for the Legislative Reception on January 24, 2013. Since this is a short session with some very critical issues for legislators, in particular the biennium budget and re-districting, our legislators will have very little free time. It would be great if you can contact your local delegation before they head to Cheyenne and personally invite them to the event. Knowing you or others from your community will be in attendance will help them prioritize their valuable time.

If you are interested, the WLA website has agendas and minutes of our most recent meetings as well as the Legislative Committees strategic

plan. Also, Marian Schulz, WLA Lobbyist will be providing weekly reports during the session. Although these are not posted on the website to ensure her inside information is not made general knowledge, I will be emailing them to <a href="mailto:all@wyla.org">all@wyla.org</a>. So look for them to keep you apprised of issues that arise during the session.

Governor Mead has included another \$3 million toward the public library endowment. Some libraries have been right on track each time dollars have been added to this important project and others are struggling. The legislation has an end date of June 30, 2014. It will most likely be the intent of the WLA Executive Board to seek an extension on that date during the 2013 legislative session. The recommendation of the Legislative Committee is that in 2012 WLA make a concerted effort to assist those libraries that are finding it harder to raise the funds in some manner. If nothing else, we all may need some cheerleading and support to renew our efforts in raising these funds locally. Prior to asking for an extension we would like some visible activity to show that our efforts have not lagged. So expect more information on this as the year progresses.

The University of Wyoming's budget requests, Community College budget requests and State Library budget requests all seem right on track at this point. School libraries will be most directly affected by what happens within the State Department of Education relating to the adoption of the "common core". During the reception, please continue to thank our legislators and any elected officials that show up for their on-going support of all types of libraries.

The Legislative Committee is in the process of making a study of successful library districting laws in other states, in particular those western states that are seeing success. We also want to look at
